#### Redevelopment Program

- York Region: 2-3 acre parcel with approx. 250 affordable apartment housing rental units for seniors
- UHS: 1 to 2 acre parcel for a future expansion
- Minto: the residual lands will be redeveloped for residential uses

#### Official Plan and Zoning By-Law Amendments

- Required to implement the proposed development to reflect the eventual approved plan
- Permissions Apartments, Townhouses (Row and Back to Back), Institutional, Retail/Service
- Performance Standards include Height, Density, setbacks – to be determined through the review of the application














